CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **RESEARCH ASSOCIATE- I** initially for a period of **06 Months** or till the project is over on a temporary contractual basis in the project entitled “**Scaling up the bio-fumigation technology for protection of stored food commodities from insect pests**” (**HCP-0031**) funded by **CSIR** tenable at the Department of **Food Protectants & Infestation Control**, CSIR-CFTRI, Mysuru, Karnataka.
