CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **PROJECT ASSOCIATE- I** initially for a period of **06 Months** or till the project is over on a temporary contractual basis in the project entitled “**Development and validation of fluori PCR--a handheld platform device for onsite detection of meat authenticity and microbial contamination (ATLAS)**” (HCP-0031) funded by CSIR tenable at the Department of **Meat & Marine Science**, CSIR-CFTRI, Mysuru, Karnataka.
